### INFLATABLE BOUNCER POLICY

Bounce House fee: \$20.00. Inflatable bouncers are only authorized in the following City locations or during approved special event activities.

#### PARK

Hans Christian Andersen Park  
Sunny Fields Park

#### PLACEMENT LOCATION

Area A or Area D (lawn area)  
Area A (lawn area just east of large BBQ)

#### IMPORTANT RULES

- Use of an inflatable bouncer is **ONLY** allowed in conjunction with a reservation of Hans Christian Andersen Park Area A or Area D or Sunny Fields Park Area A.
- No internal combustion powered generators may be used to power an inflatable bounce house within a City Park. During special events, location and power sources will be determined on an individual basis.
- Only **ONE** bouncer is allowed in the park per day.
- Stakes are strictly prohibited**; all bouncers are to be **weighted** down.
- Within Hans Christian Andersen Park, inflatable bouncers are limited in size to 16 ft x 16 ft.
- Within Sunny Fields Park, inflatable bouncers are limited in size to 18 ft x 18 ft.
- The following list of vendors hold liability insurance and are the only vendors authorized to operate inflatable bouncers within the City limits: (Solvang Parks & Recreation will call to confirm reservation. Using other agencies may lead to a full loss of deposit.)

## **RULES AND REGULATIONS**

Please observe the following rules as well as those posted throughout the Park. VIOLATION OF ANY RULES AND/OR REGULATIONS WILL RESULT IN A MINIMUM \$25.00 PER INFRACTION FEE.

1. All vehicles must be parked in designated parking lot. No parking along Coyote Creek Road and Alamo Pintado Road.
2. All equipment, event supplies and decorations brought by the user must be removed at the end of each scheduled reservation.
3. The City will not be responsible for any personal items used or left at the parks.
4. No stakes of any type are allowed in dirt or turf areas.
5. If any damage occurs to the facilities used by a group, the user and/or organization will be required to pay for the damaged property and/or replace the damaged property as determined by the City.
6. For cancellation of an event or change in use times, the City needs to be notified in writing a minimum of 48 hours prior to the start of the event. If weather cancels the event, a full refund will be issued. Notification may be e-mailed to [clibera@cityofsolvang.com](mailto:clibera@cityofsolvang.com). If the City is not notified, the user will be billed for this use time.
7. Animals must be kept on a leash at all times. S.M.C. 8-1.2 E 2, 6-1-11 B Please clean up after your pet.
8. Pony rides are prohibited.
9. All users must be out of the parks by closing time. S.M.C. 8-1-2-G
10. Please do not litter. All decorations, including tape, balloons, ribbons, streamers, confetti, and other decorating materials must be removed from the picnic area and disposed of properly. Failure to so will result in an infraction fee. Use the trash containers provided. Recycling is encouraged. S.M.C. 8-1-2 A1
11. The sale of food, drinks or alcoholic beverages is prohibited without prior written permission from the City. S.M.C. 8-1-2-0.1.2.3
12. Staff will empty trash receptacles, but the user shall remove any overflow trash. Place all excess trash into the large dumpster at the park's entrance.
13. Areas reserved will be available to renter starting at 10:00 am allowing Parks staff the necessary time to prepare the site.
14. Personal BBQs, grills, etc are prohibited. Renters must use BBQs provided.
15. Slip N Slides, water pads, water balloons, blow-up pools, etc are prohibited.
16. Softball Field Specific Rule -- Field use will be by designated areas to ensure that there is always space available for the general public. All users may use any or all parts of the turf area. However, if any member(s) from the public wish to use the turf they must be given ample room to do so. At no point may assigned users of the turf monopolize the area in such a way that members of the public are kept from also using the turf.

**No amplified sound (including radios, phones, iPods, with or without speakers, etc.) is allowed in either park. S.M.C. 8-1-2 M**

**Live music/bands are limited to string instruments only and a maximum of two (2) instruments allowed unless otherwise approved by the City of Solvang.**

**Violation of this rule will constitute full forfeiture of the security deposit.**

**NOTE: Keys must be returned within 48 hours of the date of your event. Late returns may constitute a financial penalty. \_\_\_\_\_ (Renter Initials)**
