PUBLIC NOTICE CITY OF SOLVANG UNCLAIMED PROPERTY

I, Wendy Berry, Administrative Services Manager for the City of Solvang, State of California, hereby certify that the following monies, which are not the property of the City of Solvang, have remained on deposit for a period exceeding six months without having been claimed, and that, in accordance with the provisions of Sections 50050 et. Seq., California Government Code, it is proposed and declared shall become the sole and final property of the City of Solvang on March 19th, 2026, forty-five (45) days from the first notice, unless a valid and acceptable claim is filed on or before the date to the City of Solvang.

The said monies may be released to the depositor, their heir, beneficiary, or duly appointed representative provided a claim form has been completed with the necessary information. If rejected by the Administrative Services Director, the party who submitted the claim may file a verified complaint seeking to recover all, or designated portion, of the money in a court of competent jurisdiction within the County of Santa Barbara. A copy of the complaint and summons issued thereon must be served to the Administrative Services Director within thirty (30) days of the notice of rejection. The Administrative Services Director shall then withhold the release of the portion of unclaimed money for which the court action has been filed, pending final decision of the court.
